SECTION 2: HAZARDS IDENTIFICATION

HAZARDS OVERVIEW: A clear to hazy, blue, moderately alkaline liquid having no characteristic odor. The liquid and mists may be irritating to the eyes and the skin, with some blue tinting of the skin. Inhalation of mists may be irritating to the entire respiratory tract.
