## DIRECTIONS FOR USE

• Shake well before use. • Designed to be applied by both soil and/or foliar application. • SUPER PHOS<sup>®</sup> supplies phosphorus to crops and should be applied when tissue and soil analysis identifies the need and proper rate of application for this product. • Best results will be obtained when application is concentrated in the active root zone or on the leaf surface. • Can be applied in combination with compatible plant growth regulators, pesticides, or other liquid fertilizers. • If compatibility is in question, jar test a small quantity. • Apply foliar sprays with sufficient water to ensure uniform coverage without running off leaf surfaces. • Do not apply this product foliarly in concentrations greater than 5%. • For maximum results, apply in the early morning or in the evening when air temperatures are optimum for foliar application. • Do not apply HUMA GRO<sup>®</sup> nutrients during the hottest time of the day or to plants under drought or flood stress. • Application timing, intervals and rates may vary according to individual crop requirement, stage of development, available nutrient levels in the soil, and overall nutritional status of the crop. • Applications can be made as often as every 7 to 10 days as needed. • Consult your local HUMA GRO<sup>®</sup> Representative or other agricultural specialist for crop-specific recommendations. • Do not store this product below 50°F (10°C) or above 90°F (30°C).
